

Input voltage: 120V AC, 60 Hz

- Current: Less than 7 amp max draw for 4 second
- Standard grounded plug or hard wire capability
- External user-replaceable fuse (250V, 6.3 amps)

OPERATIONAL MODES:

Operational mode may be selected to best meet user's needs. Options include:

- Autonomous Mode: Unit will run autonomously, activating automatically when room is unoccupied and adjusting frequency and duration of cleaning cycles based on motion detected by the sensor.
- Scheduled Mode: Unit will run pre-determined disinfection cycle(s) (10, 15, 20, 25 or 30 minutes) at scheduled time(s) of day. Cycle(s) will repeat every 24 hours unless power is disrupted.
- Single Cycle Mode: Unit will complete single disinfection cycle (10, 15, 20, 25 or 30 minutes) when unit is manually activated via power switch.
